FROM THE DIRECTOR

We have been active on multiple fronts since the official opening of the Brian Mulroney Institute of Government (BMIG) at StFX in the fall of 2019. In addition to devoting considerable

faculty resources to augmenting the Public Policy and Governance Program (PGOV), several new courses have been made available to our students. Moreover, thanks to the ongoing efforts of Prime Minister Mulroney and the generosity of dozens of donors, we have been able to set aside \$17 million in student bursaries and scholarships, making PGOV the best-funded undergraduate program in Canada. Students enrolled in PGOV have an opportunity to take on summer internships and to engage in experiential learning. Our two Irving Shipbuilding Chairs, Drs. Adam Lajeunesse and Peter Kikkert, have involved several students in research trips which have proven invaluable.

BMIG has also become a hive of research activity over the past 12 months. We have published books through the Institute and with leading academic presses. The Institute has recently entered into a partnership with McGill-Queen's University Press to launch a new monograph series entitled, The Brian Mulroney Institute of Government Studies in Leadership, Public Policy, and Governance. The first title in the series, Braver Canada, co-authored by Derek H. Burney and Fen Osler Hampson is to be released in the spring of 2020. Additional titles, including one on the 2019 Canadian federal election, will be published later this year.

The BMIG has also established a Distinguished Speakers Series to bring prominent academics, policymakers, journalists, and other opinion leaders to campus. Dr. Ian R. Brodie, former chief of staff to Prime Minister Stephen Harper, was our inaugural speaker. Jeffrey Simpson, award-winning National Affairs columnist with *The Globe and Mail*,

will be speaking on the relationship between Canada and the United States on 19 March 2020. We have also collaborated with several other research institutes in Canada to author the 2019 Survey of Canadians that generated widespread exposure. We are also involved in the 2020 survey.

To expand our range of research topics, the BMIG established the Resident Fellows Program in 2020. This program brings together a diverse group of talented scholars from various academic disciplines on campus to share their expertise and knowledge. Efforts are also underway to create a Non-Resident Fellows program to encourage scholars, policy practitioners, and other public policy experts to take up residence at the Institute for brief periods. We are also in the process of establishing a Digital Policy Lab with a focus on public opinion and voting behaviour. Housed in Mulroney Hall, the Lab will be an environment in which students and researchers may explore the reactions of Canadians to various public policy issues. With the support of IBM, the Lab will further enhance the Institute's profile.

Finally, BMIG has greatly increased its media profile over the past year. Scholars at the Institute have given dozens of interviews to the print and broadcast media on a host of public policy issues. We have no doubt that our media presence will continue to grow.

We are very proud of what we have accomplished since our official opening. There is considerable reason to be optimistic and excited about our future. With continued support, we will continue to help train students to become leaders in the governmental and non-governmental community, and, through our research and outreach activities, will fill an important niche on the public policy landscape.


The Brian Mulroney Institute of Government was born out of the Rt. Hon. Brian Mulroney's belief that the education and encouragement of future leaders are the best paths to creating a stronger Canada. These beliefs and the values that support them were shaped and guided by the Prime Minister's experiences as an undergraduate at St. Francis Xavier University. Locating the BMIG on StFX's picturesque campus brings his commitment to promoting civic engagement full circle. Mulroney Hall is a state-of-the art building designed to maximize accessible areas for student and community gatherings, and productive study in bright, open spaces. Over a dozen classrooms and research spaces technology and smart telepresence capabilities to enhance the student learning experience. Mulroney Hall's Joyce Family Atrium, the "Campus Living Room," is a large multi-level, multi-purpose space envisioned as a gathering place for students. The building's 300-seat Barrick Auditorium has already hosted campus and community events, and its dedicated art gallery space will be completed in Spring 2020.

Mulroney Hall also celebrates the Prime Minister's lifelong dedication to public service. The building features several interactive displays and exhibits that explore Mr. Mulroney's life at StFX through his time as the 18th Prime Minister of Canada. Immersive pods along Scholar's Walk provide videos of Mr. Mulroney's appearances and speeches, including digital photo albums sharing pictures of the diverse visitors he encountered while in office. Mulroney Hall's central feature is an exact replica of the Prime Minister's office, including the historically accurate view of Parliament Hill as seen from the office's windows.

Mulroney Hall's interior and exterior are as inspiring and innovative as the centre for undergraduate training and research it houses.




Publications



The Canadian Naval Review is a hybrid academic/ professional journal examining a wide range of maritime security issues. Looking at strategic concepts, policies, oceans policy, and marine affairs this initiative brings together members of the Canadian defense and academic communities to promote strategic thinking and good security policy.

As part of the BMIG's efforts to generate timely and relevant policy research the Institute has partnered with *The American Review of Canadian Studies* to publish a special issue examining the impact of the Trump administration on Canada-US relations. The issue's articles are from a distinguished group of scholars, covering the economic, social, and diplomatic fields.





This volume, edited by BMIG Adjunct faculty Whitney Lackenbauer, is a comprehensive look at Canadian defence and security governance in the Arctic. Distributed widely to Armed Forces and government officials, Whole of Government Through an Arctic Lens has become the go-to source for understanding how Canadian security agencies operate and cooperate in the North.


RESEARCH AT WORK

BMIG STUDIES IN LEADERSHIP, PUBLIC POLICY, AND GOVERNANCE

The BMIG has partnered with McGill-Queen's University Press for a forthcoming publication series. Titles in this series address critical issues facing Canada at home and abroad and the efforts policymakers at all levels of government have made to address a host of complex and multifaceted policy concerns. Books in this series receive financial support from the BMIG. In keeping with the Institute's mandate, these studies explore how leaders involved in key policy initiatives arrived at their decisions and what lessons can be learned. Combining rigorous academic analysis with thoughtful recommendations, this series compels readers to think more critically about how and why elected officials make certain policy choices, and how, in concert with other stakeholders, they can better navigate an increasingly complicated and crowded marketplace of ideas.

ARCTIC OPERATIONAL HISTORIES







STUDENTS AT SEA

In 2020, the BMIG is partnering with the Royal Canadian Navy on the new "Students at Sea" initiative. In experiential learning at its most exciting, groups of students from security studies courses will travel to the Canadian Navy Yards in Halifax to tour submarines and patrol ships and head out into the Atlantic aboard a frigate. Getting out of the classroom and out to see how things are done is critical. Defence studies just got more interesting.



STUDENTS NORTH

In October 2019, BMIG Chair Peter Kikkert travelled with several students to High Arctic communities that few Canadians will ever visit. Assisting Kikkert to design and implement workshops, focus groups, and interviews in Kugluktuk, Cambridge Bay, and Gjoa Haven, Nunavut, these students made a meaningful contribution as part of a larger project examining search and rescue and emergency management in the North. Early in 2020, Dr. Kikkert travelled North again with two more PGOV students, visiting the High Arctic Research Station in Cambridge Bay while facilitating the Kitikmeot Roundtable on Search and Rescue. While other schools might rely on graduate students to conduct this kind of work, the unique emphasis that the BMIG places on the undergraduate experience ensures that these exceptional opportunities are available to our undergraduates.

ENGAGING STUDENTS

As a primarily undergraduate institution, StFX and the BMIG offer students unparalleled opportunities to work with their professors in cutting-edge research.

Student engagement cornerstone of the BMIG's teaching philosophy, and our chairs are actively engaged preparing undergraduates real-world for responsibilities. Working with faculty advisors, students serve as assistant editors, managers, and researchers with the Canadian Naval Review, the Arctic Operational Histories, and the BMIG's occasional papers. Over the past year, students have joined exciting research trips Washington, DC and Ottawa while working with BMIG Chairs on areas as diverse as Chinese maritime policy to remote Search and Rescue.



SCHOLARSHIPS

Student scholarships, bursaries, and experiential internships are a significant and defining feature of the Public Policy and Governance program at StFX. The following provides an outline and summary of student funding opportunities that will be available to students in 2020–21.

The Right Honourable Brian Mulroney Scholarships [2 each year]

\$60,000 (Awarded over 4 years)

Renewable scholarships awarded to 2 students per year for a total of 8 award holders.

Sobeys Entrance Scholarship [2 each year]

\$40,000 (\$10,000/year, renewable for 4 years)

Open to all students enrolling into the PGOV program directly from high school with a minimum entrance average of 85%. Awards are renewable for 4 years with continuation in Bachelor of Arts with Major or Minor in PGOV and an 80% average.

Irving Family Scholarships [3 each year]

\$20,000 (\$5,000/year, renewable for 4 years)

Open to all students enrolling into the PGOV program directly from high school and to students already enrolled in a BA with a Major or Minor in PGOV. A minimum 85% average is required for entrance scholarship and a minimum 80% average in the previous year required for those already enrolled. Awards are renewable for 4 years with continuation in Bachelor of Arts with Major or Minor in PGOV and an 80% average.

Mila Mulroney Scholarship for African Nova Scotian Students [4 each year]

\$15,000 (\$3,000, renewable for up to 4 years)

Open to all African Nova Scotian students enrolling into the PGOV program directly from high school or to African Nova Scotian students already enrolled in a Bachelor of Arts with a Major or Minor in PGOV, or a Major in Political Science, Economics, Developmental Studies, or Women and Gender Studies. A minimum 70% average is required for the entrance scholarship and a minimum 80% average in the previous year required for those already enrolled. This award is renewable up to 4 years with maintenance of a 70% average.

The Weston Family Scholarship for International Exchange [6-8 each year]

\$6,000

This award provides funding for student international exchanges. Awards would support one semester at an international partner university program offering courses equivalent to those at StFX and thus eligible for course credit at StFX. Awards are valued at up to \$6,000 each for students enrolled in a BA with Major or Minor in PGOV. Students may re-apply to receive the award in multiple years.

Joyce Family Bursaries [25 each year]

\$1,000-\$4,000

Awards are based on student financial need and range from \$1,000 to \$4,000. First-year recipients must be enrolled in the PGOV program. Bursaries will be renewable in second, third, fourth years for students that have declared a Major or Minor in PGOV. Bursaries are also available to students already enrolled in a Bachelor of Arts program and taking courses in Public and Governance.

RBC Foundation Research Internships [8 each year]

\$6,250

This funding will support up to 8 summer research internship awards valued at \$6,250 each (which includes applicable benefits) for students enrolled in Bachelors programs at StFX. Students require a StFX faculty mentor from an appropriate area of expertise, who is willing to supervise the student during the internship. Eligibility requires enrollment in full-time studies in a StFX Bachelor's degree during the most recent complete academic term (prior to the application deadline) and intent to return to full-time studies at StFX in the term following the Research Internship.

Joseph Armand Bombardier Student Internships [6 each year]

\$6,000

These awards will support full-time summer employment within a public policy or governance-related position at a government or non-government organization. Internships will be awarded to students enrolled in a Bachelor of Arts with Major or Minor in PGOV at StFX. Students may re-apply to receive the award in multiple years.

Dahdaleh Scholarship for Indigenous Students [4 each year]

\$15,000 (\$3,000/year renewable for up to 4 years)

Open to all Indigenous Nova Scotian students enrolling into the PGOV program directly from high school or to Indigenous Nova Scotian students already enrolled in a Bachelor of Arts with a Major or Minor in PGOV, or a Major in Political Science, Economics, Developmental Studies, or Women and Gender Studies. A minimum 70% average is required for the entrance scholarship and a minimum 80% average in the previous year required for those already enrolled. This award is renewable up to 4 years with maintenance of a 70% average.

David & Hildegarde Mahoney Scholarship

\$10,000

This award is available to a student enrolling in the PGOV program directly from a U.S.-based high school.

Eldee Foundation - UN Service Learning Bursary [4 each year]

\$4,000

Available to students participating in Model UN.

David Marley Scholarship [4 each year]

\$8,000

Available to students enrolling in the PGOV program directly from high school.

Michael Mulroney Scholarship [4 each year]

\$10,000

Available to students enrolling in the PGOV program directly from high school.

Sister Peggy Butts Bursary [4 each year]

\$7,000

Available to students enrolling directly from high school.

Thomas O'Shea Scholarship [4 each year]

\$7,000

Available to students enrolling directly from high school.

Bogdanka Pivnički Scholarship [4 each year]

\$7,000

Available to students enrolling in the PGOV program directly from high school.

Guy R. Savard Bursary [1 over 4 years]

\$50,000 (\$12,500/year renewable for 4 years)

Open to students from rural Quebec enrolling directly from high school/CEGEP and taking courses associated with Public Policy and Governance Program. Must demonstrate financial need.

Scotiabank Entrance Scholarship [1 each year]

\$16,000 (\$4,000/year renewable for 3 years)

Open to all students enrolling into the PGOV program directly from high school. A minimum 85% average is required for entrance scholarship. Awards are renewable for 4 years with continuation in Bachelor of Arts with Major or Minor in PGOV and an 80% average.

GOVERNANCE IN PERSON

Public policy and governance students experienced their studies firsthand when they travelled to Halifax on November 8, 2019, to meet and engage with provincial politicians and policymakers. Dr. Peter Kikkert, BMIG's Irving Shipbuilding Chair in Arctic Policy, organized the trip with Antigonish MLA and Minister of Health and Wellness Randy Delorey. Students were able to meet with officials on the Executive Council and from several departments, including health, finance, environment. The trip exposed students to the different career pathways that public policy can set them on and provided them with an opportunity to hear from the actual practitioners on the skills they should be working on complete their they undergraduate degree. Students encouraged questions related to the issues

and themes they have been studying in their courses. Many of the participants spoke highly of being able to see a government in action and the positive impact of experiential learning on their studies in general.

BMIG ARCHIVAL INTERNS

For Summer 2020, the BMIG will be recruiting three students to develop a policy archive that will be hosted on the Institute's website. The students will be gathering and organizing primary documents related to policy decisions covering subjects such as Canada-US relations, free trade, and the North and Arctic. Students will have an opportunity to conduct archival research for an interdisciplinary project at the intersection of governance studies and public history. The documents, which will include speeches, memoranda, as well as government materials, will form the basis of what the BMIG anticipates will be a searchable "one-stop" policy archive for students, scholars, and the public at large.



Public Policy Engagement

The BMIG is dedicated to policy-relevant supporting research analysis with the aim of championing the creation of evidence-based public policy. Central to this dedication is the BMIG's deep commitment to policy engagement. public Encouraging and facilitating faculty interactions policymakers and practitioners establishes new lines communication that serve to strengthen the exchange of ideas between stakeholders and scholars. As active participants in the policymaking process, whether its testifying before parliamentary committees or speaking directly to government officials and community leaders, BMIG associates are not only able to identify gaps in public policy coverage and challenges to implementing public policy but can also expedite solutions to these issues. Informed and public policy dynamic engagement effects real-world change. This underscores the important ways in which have scholarship can transformative impact on public policy. And this can only come from engaged scholars.

DISTINGUISHED SPEAKER SERIES

In 2019, the BMIG launched its Distinguished Speakers Series. The series brings prominent Canadian and international academic and professional experts to the Institute to share their unique perspectives on public policy and governance. Ian

R. Brodie, former chief of staff to Prime Minister Stephen Harper, was the series' inaugural speaker. The series' mission is to foster debate and dialogue, actively engaging students, faculty, and the larger StFX community in conversations about understanding the power of public policy. Through the Distinguished Speakers Series, the BMIG strives to inspire students to make a meaningful impact on their communities and the world at large. The BMIG will welcome Jeffrey Simpson, renowned Canadian journalist and former National Affairs columnist for *The Globe and Mail*, in March 2020.



BMIG Chair Helping to Shape Arctic Policy

One of Canada's most sought-after experts in the field of Arctic policy and security, Adam Lajeunesse is a frequent contributor to government policy consultations. He has presented evidence to Canadian Senate and House of Commons committees and lectured to the Departments of National Defence,

Global Affairs and other Canadian security agencies. He is a regular participant at the federal government's interdepartmental Arctic Security Working Group, has taught at the Canadian Forces College, and is a regular speaker at the NATO Defence College in Rome. Recently, Lajeunesse was one of two academics invited to participate in the revision of the Canadian Army's Arctic Operating doctrine; that same year he participated in policy reviews by both the Departments of National Defence and Global Affairs and spoke at the Arctic Security Forces Roundtable, a four-star meeting of NATO defence leaders.



WORKING WITH NORTHERNERS TO DEFINE ARCTIC SECURITY

Given his work on safety issues, emergency management, and search and rescue (SAR) in the Arctic, Peter Kikkert has been working to establish strong relationships with community-based SAR organizations throughout Nunavut, the Canadian Coast Guard (CCG) and Canadian Coast Guard Auxiliary, Joint Task Force North and 1 Canadian Ranger Patrol Group (1CRPG), and Nunavut Emergency Management (NEM). This policy engagement lead to an invitation to deliver a briefing on community-based SAR to the Arctic Security Working Group in November 2019, participation in 1CRPG's Ranger and Junior Canadian Ranger leadership training in Yellowknife, the chance to observe training and exercises in the North, and requests to produce briefing notes for NEM, CCG, and 1CRPG. Kikkert also organized the Kitikmeot Roundtable on SAR in January 2020, which brought together government agencies and community practitioner to discuss the state of SAR and emergency response in the Kitikmeot Region of Nunavut.

Finally, Kikkert was invited by the U.S. State Department to participate in the International Visitor Leadership's Program on Arctic SAR which ran from 18 May to 8 June 2019. With four other Canadian academics and practitioners, Kikkert engaged with American organizations and agencies involved in SAR operations in Washington, Miami, Seattle, Juneau, and Anchorage. These meetings included significant discussion of current policies, challenges opportunities, in capabilities, gaps recommendations how strengthen on to Canadian-American cooperation to improve Arctic SAR.



WORKING WITH THE MEDIA

An important component of the BMIG's commitment to engaging communities in debate and dialogue about the impact of public policy and governance is providing accessible knowledge and expertise on these subjects. As such, many of the BMIG's faculty and fellows are regular contributors to local, national, and international media platforms, including print, radio, television, and podcasts.

The Institute's director, Dr. Donald E. Abelson, is a sought-after media contributor. He has appeared on CTV News Channel and in US News & World Report and The Toronto Star, among many others. In 2019, Dr. Abelson made over 30 media appearances, discussing Canada-US relations, the Democratic primaries, and the impeachment of President Donald Trump.

Dr. Adam Lajeunesse, the Institute's Irving Shipbuilding Chair in Canadian Arctic Marine Security, appeared frequently on television and radio in 2019 weighing in on American Arctic policy, Arctic sovereignty, and Canada's naval capabilities in the Arctic for outlets such as Global News, CBC News, and *The Walrus*.

Resident Fellows Dr. Yvon Grenier and Dr. James Bickerton are regular radio guests during federal election cycles. Dr. Grenier is also a regular commentator for Radio Canada and the CBC, where he shares his expertise on Latin American governments.



The People

RESEARCH CHAIRS

Donald E. Abelson, PhD is Director, Brian Mulroney Institute of Government, Steven K. Hudson Chair in Canada-US Relations, and Professor, Political Science, St. Francis Xavier University. He is the author of several books including Do Think Tanks Matter? Assessing the Impact of Public Policy Institutes (3rd ed., McGill-Queen's University Press 2018), Think Tanks, Foreign Policy, and Geo-Politics: Pathways to Influence (Routledge 2017, with Stephen Brooks and Xin Hua), and Northern Lights: Exploring Canada's Think Tank Landscape (McGill-Queen's University Press 2016). In addition to his research and teaching interests in the fields of comparative politics and international relations, Dr. Abelson is a regular commentator on major media outlets throughout North America and Europe.





Adam Lajeunesse, PhD is the Irving Shipbuilding Chair in Canadian Arctic Marine Security and an Assistant Professor in Public Policy and Governance. Dr. Lajeunesse specializes in Northern sovereignty and security and is the author of the award winning Lock, Stock, and Icebergs: A History of the Northwest Passage.

Dr. Peter Kikkert is the Irving Shipbuilding Chair in Arctic Policy and Assistant Professor in Public Policy and Governance. Dr. Kikkert's research focuses on safety, security, sovereignty, and governance issues in the polar regions. He has published on the evolution of international law in the Arctic and Antarctic, and the Canadian-American defence relationship in the North.



The Brian Mulroney Institute of Government Resident Fellows Program

In 2019, the BMIG established its Resident Fellows Program to create a network of scholars at StFX whose research has implications for the conduct and implementation of public policy and/or issues relating to governance. During their three-year appointment, each Fellow will present a public lecture and contribute to BMIG's Occasional Paper series. The inaugural class of eight Resident Fellows and two Distinguished Fellows are recognized for their expertise across a range of disciplines (including political science, philosophy, sociology, health equity and social justice, conflict resolution, finance, and education) and will play a major role in enhancing the Institute's research capacity

Distinguished Fellows

Dr. Douglas M. Brown is Associate Professor of Political Science at StFX. His research areas include intergovernmental relations in Canada, fiscal federalism in Canada, and Canadian regional politics with a focus on the Atlantic Provinces.

Dr. Peter Clancy is a Senior Research Professor in the Department of Political Science at StFX. His work centres on the interplay of economic and political interests in settings such as business politics and natural resource industries.

Resident Fellows

Dr. James Bickerton is Professor of Political Science at StFX. His research interests are in the areas of federalism, regionalism, and electoral politics in Canada.

Dr. Patricia Cormack is Full Professor in the Department of Sociology at StFX. She researches the place of the Canadian state in everyday life and the state's role in cultivating nationalism.

Dr. Yvon Grenier is Professor of Political Science at StFX. His current work examines Canadian foreign policy toward Cuba, Mexico, and Venezuela, with a focus on human rights and the promotion of democratic values.

Dr. Jamie Levin is Assistant Professor in the Department of Political Science at StFX. His work focuses on the role of weapons in the resolution of civil wars.

Dr. Katie Aubrecht is Canada Research Chair in Health Equity and Social Justice and Assistant Professor in the Department of Sociology at StFX. She leads an interdisciplinary research program that maps health services, social policies, and community resources related to marginality, mental health, and resilience, with a focus on rural communities in Atlantic Canada.

Dr. Louis Groarke is Full Professor in the Philosophy Department at StFX. His research focuses on political theory, moral philosophy, aesthetics, logic, Aristotle, and the history of philosophy.

Dr. Bhavik Parikh is Associate Professor of Finance at the Schwartz School of Business at StFX. His research focuses on international finance, tax evasion, and Islamic finance.
